Williams Grove Historical Steam Engine Association, Inc RULES FOR CAMPING

Any individual reserving a campsite must acknowledge receipt of these rules and is responsible for those using their site.

1. All Campsites are primitive. Water, sewer and electricity are not provided and we do not have a dump station. Absolutely no discharge of waste (septic) water and/or gray (dish, bath) water on the ground by order of PA State Law.

2. You must be 21 or older to rent a campsite.

3. WGHSEA, Inc is not responsible for loss or theft of articles or damage caused by fire or accidents.

4. Trash should be placed in receptacles provided.

5. FIRES: No on-ground burning allowed. Fire bowls and pits above the ground are allowed to be used but all fires are prohibited during municipal burn bans. No burning of trash is allowed. All campfires must be in a safe area where they will not constitute fire hazards to structures, RVs, vehicles or vegetation. Fires must be attended at all times and fully extinguished when leaving the campsite.

6. Golf Carts and UTVs are allowed with a paid golf cart permit and proof of insurance. Mini-bikes, ATVs Dirt Bikes are not permitted on the grounds.

7. ALL CHILDREN UNDER 18 MUST BE AT THEIR SITE BY 11:00 PM. All children 13 and under must be with an adult after dark. Parents are responsible for their children. Children under the age of 16 are not to be left unattended on WGHSEA, Inc property at any time. Children 16-17 years old are not permitted on the grounds after 10 PM without a parent or guardian.

8. DO NOT PARK IN SITES YOU HAVE NOT PAID FOR. Vehicles parked in sites rented by others will be towed at the owner's expense.

9. Speed limit of 5 MPH is to be observed on the grounds at all times for ALL MOTORIZED VEHICLES.

10. PETS must be leashed at all times. CLEAN UP AFTER YOUR PET and respect others by keeping your pet controlled and quiet. DO NOT leave your pet unattended. No vicious or harmful pets allowed. Pet owners are 100% liable for any harm to others caused by their pets.

11. Quiet hours are from 11:00 PM to 6:00 AM. Activities on the grounds may create noise outside of this timeframe but noise from campsites should be limited. Limit movement after 11:00 PM to going to and from an activity or another campsite. Anyone not listed below as a camper in your party is not permitted on the grounds after 11:00 PM unless participating in or viewing a WGHSEA, Inc activity. Large gatherings are not permitted after 11:00 PM and anyone not listed on a campsite form will be asked to leave.

12. Inverter generators are permitted to be run 24/7. Louder generators are only to be run from 6:00 AM to 11:00 PM with the exception of those with a need for a medical device at night. Proof of medical need should be available upon request. Generators must be kept within your own campsite and should not be blowing exhaust or creating excessive noise for adjacent campsites.

13. WiFi is not provided to campers, it is for property security only.

14. All RVs are TO BE REMOVED from the grounds within 3 days of the end of each event unless prior arrangements have been made with the camping committee.

Enforcement of these rules is at the discretion of the Executive Committee and Board of Directors. VIOLATION OF THESE RULES CAN RESULT IN IMMEDIATE REMOVAL FROM THE PROPERTY AND PERMANENT BARRING. Failure to sign the rules will result in loss of camping privileges at WGHSEA, Inc.
